#### **Precautions for safe handling**

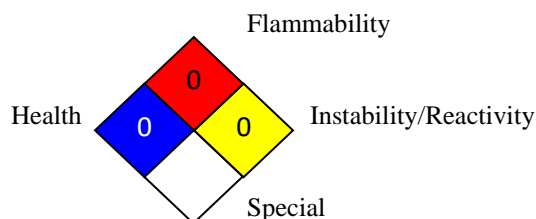
