Direct contact may cause irritation, redness, tearing and blurred vision.

Signs of lung involvement include increased respiratory rate, increased heart rate, and a bluish discoloration of the skin. Coughing, choking and gagging are often noted at the time of aspiration. This product has laxative properties and may result in

abdominal cramps and diarrhea.

**SECTION 4** 

FIRST AID MEASURES

Eye contact:

Check for and remove contact lenses. Flush eyes with cool, clean, lowpressure water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of the eye and eyelld tissue. If irritation persists seek medical attention. If material is hot, treat for thermal burns and take victim to hospital

immediately.

Skin contact:

Remove contaminated clothing. Wash contaminated area thoroughly with soap and water. If redness or irritation occurs, seek medical attention. If material is hot, submerge injured area in cold water. If victim is severely burned, remove

Inhalation:

to a hospital immediately. Wash contaminated clothing before reuse. If overcome by inhalation of hot vapors, remove to fresh air. Use oxygen if there is difficulty breathing or artificial respiration if breathing has stopped. Do not leave victim unattended. Seek immediate medical attention if necessary.

Ingestion:

Do not induce vomiting unless directed by a physician. During vomiting there is a danger of aspirating liquid into lungs, causing serious damage and chemical pneumonitis. If spontaneous vomiting occurs keep head below hips to prevent aspiration and monitor for breathing difficulty. Keep affected person warm and at rest. Seek immediate medical attention.

## SECTION 5

### FIRE FIGHTING MEASURES

Use water spray, dry chemical, alcohol foam, all purpose AFFF or carbon dioxide to extinguish fire.

Special firefighting procedures:

Evacuate area and fight fire from a safe distance. If leak or spit has not ignited, ventilate area and use water spray to disperse gas or vapor and to protect personnel attempting to stop a leak.

Use water spray to cool adjacent structures and to protect personnel. Shut off source of flow if possible (safely). Stay away from storage tank ends. Withdraw immediately in case of rising sound from venting safety device or any discoloration of storage tank due to fire.

Fire fighters must wear MSHA/NIOSH approved positive pressure breathing apparatus (SCBA) with full face mask and full protective equipment.

Unusual fire & explosion hazards:

Dense smoke may be generated while burning. Toxic fumes, gases or vapors may evolve on burning. High temperatures (>200°C/3 92°E) may create heavy flammable vapors that may settle along ground level and low spots to create an invisible fire hazard.

Fires involving this product may release oxides of carbon, nitrogen, sulfur, phosphorus; reactive hydrocarbons and imitating vapors.

### SECTION 6

### ACCIDENTAL RELEASE MEASURES

Spill control procedures (land):

Immediately turn off or isolate any source of ignition (pilot lights, electrical equipment, flames, heaters, etc.). Evacuate area and ventilate. Personnel wearing proper protective equipment should contain spill immediately with inert materials (sand, earth, chemical spill pads of cotton) by forming dikes. Dikes should be placed to contain spill in a manner that will prevent material from entering sewers and waterways. Large spill, once contained, may be picked up using explosion proof, non-sparking vacuum pumps, shovels, or buckets, and disposed of in suitable containers for disposal. If a large spill occurs notify appropriate authorities. In case of road spill or accident contact Chem-Trec (800-424-9300).

Spill control procedures (water):

Try to contain large spills with floating booms to prevent spill from spreading. Remove from surface by skimming or with suitable adsorbents. If a large spill occurs notify appropriate authorities (normally the National Response Center or Coast Guard at 800-424-8802).

Waste disposal method:

Most oil based products are incinerated, land-filled or reclaimed. All disposals must comply with federal, state, and local regulations. The material, if spilled or discarded may be a regulated waste. Refer to state and local regulations. Impervious gloves such as neoprene or nitrile rubber to avoid skin sensitization
